

Frequently asked question in respect of Fund Wing and reply thereto in terms of the provision of Haryana GP Fund Rules, 2006

Whether an employee joined prior to 01.01.2006, is eligible for allotment of GP Fund account number?	A person who has joined the Hr. Govt.service before 1.1.2006 on regular basis is eligible for allotment. After 1.1.2006, New Pension scheme is in operation. (Haryana Govt. Letter No. 2150 /2008-1(Pen) dated 15/02/210.)
How much amount should be subscribed to G. P. Fund?	Minimum 8% and maximum monthly Pay including grade Pay can be subscribed to G.P. Fund every month. No Interest will be allocated on subscription made over and above of such limits. (Rules 10(1)(b),12(9) of Haryana GP Fund Rules, 2006).
Minus balance has appeared in a GP Fund account. Whether it attracts any penalty?	If the balance withdrawn from GP Fund account is more that the available balance of subscriber accounts, it leads to minus balance Penal interest @ 2.5% over and above the prevailing rate will be charged. (Rules 12(7) of Haryana GP Fund Rules, 2006).
Whether an employee dismissed from service is entitled for interest on GPF Final payment?	Dismissed subscriber is entitled to interest upto previous month on which final order of dismissal is passed. (Rules 12(8) of Haryana GP Fund Rules, 2006).
What are requirements for sending FP case?	In case of Final payment on superannuation:- Last Fund Deductions made and Certificate of Advances during 12 months prior to retirement. List of family members duly signed by DDO in case of death. In case of dismissal:- Copy of order of dismissal and a certificate to the effect that no departmental appeal is pending against these orders. The case should be forwarded by next higher authority. (Form No. PF 5, 6 of Haryana GP Fund Rules, 2006).
To which head of account an Non AIS subscriber should deposit GP Fund?	Non AIS subscriber, GP Fund credit should be deposited under head 8009-01-Civil-101-GPF. (As per List of Major, Minor head)
To which head of account an AIS subscriber should deposit GP Fund?	For AIS subscriber, GP Fund credit should be deposited under head 8009-01-Civil-104-AIS. (As per List of Major, Minor head).
Whether a person retiring within 6 months can obtain an advance after submitting GP Fund final payment papers?	After submitting papers of Final payment, Advance can be availed only after getting the sanction acknowledged from A.G. Office. (Rules 16(12) of Haryana GP Fund Rules, 2006).

<p>How an employee, rejoined after dismissal/removal can re-operate his GP Fund?</p>	<p>On rejoining a subscriber shall repay any amount paid to him from the GP Fund alongwith interest at the rate prescribed in GP Fund rule. The amount so repaid shall be credited to his account in the Fund. (Rules 24(1)(ii) of Haryana GP Fund Rules, 2006).</p>
<p>When will GP Fund of a disappeared subscriber be paid to his/her spouse?</p>	<p>Non traceable report is to be obtained from police in the first instance. An indemnity bond to the effect that all payment will be adjusted in case subscriber appears on scene and makes any claim the payment will be made. (Rules 24(3) 24(7) of Haryana GP Fund Rules, 2006).</p>
<p>I have not received or received but forgot the PIN (Personal Identification Number) to access the status of my GPF account/GPF final payment.</p>	<p>Register a complaint on this site indicating your name, GPF account No. (with prefix series such as GA, PWD, MED,) particulars of present DDO, correspondence address etc.</p>
<p>My GPF account does not show credits upto the ongoing month or shows some credits missing.</p>	<p>(i) Transmission of GPF schedules to the respective GP Fund sections for posting in individual PF accounts takes time and posting of Accounts of a particular month is completed and uploaded on the site after a gap of about 4 months (say status of posting for the month of April is displayed in August). Hence, please wait for about 4 months to know the status of ongoing month.</p> <p>(ii) In case of missing credits, please send complete detail of subscriptions showing Treasury Voucher No./Month, Total amount of Bill, copy of GPF schedules for that particular month etc. through the DDO</p>
<p>I have not received GPF statement for a particular year.</p>	<p>You can download the same from the site duly entering your PIN.</p>
