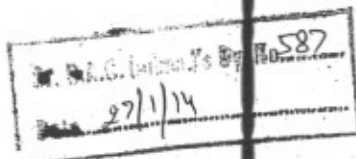


Sub: General Clarification regarding counting of broken spells of ad-hoc promotion for increment - reg.
