**Subject: Defined Contributory Pension Scheme of the State Government-
Guidelines for withdrawal of Pension corpus on superannuation.**

Sir,

I am directed to invite your attention towards Finance Department's instructions issued vide No. **2/47/2007-1Pension(FD)**, dated **23rd July 2012** wherein detailed guidelines had been issued for **withdrawal of Pension corpus on superannuation** in respect of New Pension Scheme.

Now after careful consideration on the basis of guidelines/instructions approved by Pension Fund Regularity & Development Authority (**PFRDA**) vide file No. PFRDA/20/3/17/PDEX/10 dated **23-10-2013** & PFRDA/20/34/111 dated **6-11-2013**, the **following provision** has been inserted after **para 3** as **para 3A** in the existing guidelines issued vide no. 2/47/2007-1Pension, dated **23-07-2012**.

3A *"It has been decided to provide **an option to withdraw the entire accumulated pension wealth** to subscribers of New Pension Scheme(NPS) subject to the following conditions;—
The accumulated pension wealth in the subscribers permanent retirement account is **equal to or less than Rs. 2,00,000/-**(Rs. Two lacs only) at the **time of superannuation** for Government employee subscribers.
The subscribers wishing to exercise this option shall have to fill the enclosed request form alongwith the New Pension Scheme(NPS) withdrawal form while submitting the same to their DDO's."*

The other terms and conditions of letter dated **23-07-2012** shall remain unchanged.

You are requested to bring the above guidelines/instructions in the knowledge of all DDOs/employees for strict compliance.
