Subject:- Grant of benefit under amended Rule 3.17A (f) (i) of CSR Vol. II.

Sir/Madam,

Kindly refer to this department's notification No. 4/51/2013-2Pension dated 28.05.2014 vide which rule 3.17 A(f) (i) of CSR Vol. II was amended w.e.f. 12.12.1997, in compliance of order of Hon'ble Punjab & Haryana High Court, in the following manner:-

"In the Punjab Civil Services Rules, Volume-II, in Rule 3.17, in clause (f), in sub-clause (i), for the words "half of the period", the words "full period" shall be substituted."

It has come to the notice of Finance Department that even after issue of notification regarding amending the above rule, various departments are not granting the benefit to the concerned. Due to this, the affected official(s) have approached Courts for claiming such benefit. The Hon'ble High Court has also taken serious view of non granting of benefit under above rule even after its amendment w.e.f. 12.12.1997.

So, it is requested to ensure compliance of the notification dated 28.05.2014 for grant of benefit to the employee concerned immediately. Non-compliance, of above notification will invite disciplinary action against the officials/officers responsible for it.

The above instruction may please be brought to the notice of all official/officers concerned for strict compliance.
